Alois Joseph Bittner of Garwood passed away on February 9, 2012 at the age of 97. He was born on June 19, 1914 to John Alosisia Wesselski Bittner. He worked as a meat butcher for the F & W Food Store. He served in the US Army during WWII as a military policeman.
